Privacy Policy

This Privacy Policy describes Colfax International's practices regarding the collection, use, and disclosure of personal and account information that may be collected from visitors and users of this "Website" who agree to the terms and conditions of access and use of the Website. If at anytime you disagree, do not proceed to access and use the Website.

In this policy, "**personal and/or account information**" means, your name, company name, account number, address, telephone number, and e-mail address plus any other information that personally identifies you, or would permit us to contact you, and "we" and "us" means Colfax International and our authorized employees and representatives.

Your privacy is important to Colfax International and this policy describes the precautions we take to protect it.

We reserve the right to modify this privacy policy from time to time. The effective date noted above will indicate the date that this policy was last updated. Check this policy for any changes each time you visit our Website.

How much information must you provide via the Website?

The submission of personal and/or account information is optional and purely voluntary. You may phone, fax or use regular mail to provide us your personal and/or account information in lieu of providing it via our Website.

The amount and type of information we collect from you depends on your activities and the use of our Website. Below, we explain what information we collect.

When you browse our Website:
